An amendment was proposed and approved in chapter number 5, Officers of the University, para 10 of the First Statutes of the BML Munjal University;

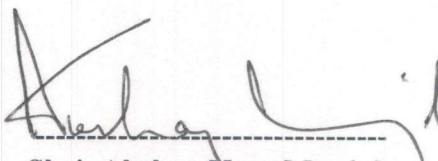

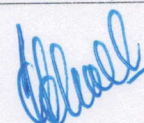

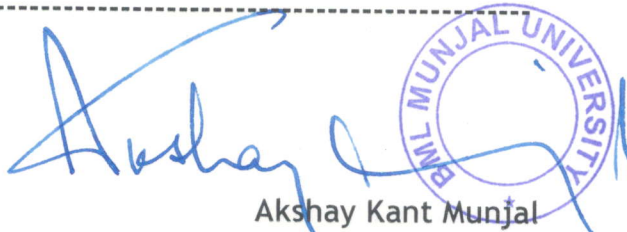
